

CHAIRMAN'S REPORT 2012



I am pleased to present the Chairman's Report for the calendar year 2012. In financial terms we have been very fortunate to have received a "one-off" extremely generous donation from an individual who requested anonymity, without which we should only have broken even this year. In human terms, the number of persons seeking our help continues, predictably, to increase.

We have the constant conundrum of wishing to be discreet about those who contact us, all the while being well aware that if we broadcast details we might well find funds more easily to be able to help more! Confidentiality is vital. People who need help might not approach us if they feared

their problems becoming public. Suffice to say that in 2012 we have dealt with cases of de facto deportation, persons needing financial support because of mental health problems, continuing support for those whose families can no longer provide and a whole range of emergency and temporary crises for Britons and their dependants. We currently have more than twenty people receiving help in one way or another and we handle many more individual queries that arise during the course of a year.

The work is done by our Committee Members who operate under no other guidelines than trying to assist when no other help is available, providing that they are sure that it is a genuine case of need for a qualifying person. The requirements can be anything from a comforting talk to practical advice as to how and where to get help or obtain temporary or even continuing financial assistance. Our thanks to all those who give their time to do this. As our members will be well aware, we work with other organisations whose activities overlap with ours, and we thank in particular the Royal British Legion, the Community Help Service, the British and Commonwealth Women's Club of Brussels, our Embassy and the Wednesday Club for their cooperation and support. Special thanks also to BBCA, whose fund-raising for charity through the Duchess of Richmond's Ball is an enormous financial help in our work.

We still have work to do to increase our donor database. A glance at the archives shows that the British Community and British companies established in Belgium gave generously and in large numbers in the past. Sadly those days are long gone and we have to rely on the generosity of the few people we can reach with direct appeals – a number that continues to decrease for all the obvious reasons.

On a brighter note, the website has had some success, to judge from the number of hits it has registered, and we have received emergency request for help via the automatic contact facility on the site. We look forward with some optimism to continuing our work in the community as we approach our 200th anniversary in 2015!

BRITISH CHARITABLE FUND



The BCF was created by the Duke of Wellington in 1815 following the Battle of Waterloo to take care of wounded soldiers and their families. Thus, for nearly 200 years, the BCF has been providing help. The persons seeking help have changed as have their circumstances but there will always be people who, for a whole variety of reasons, require emergency financial help and those who have longer term needs for assistance, advice and contact.

The Fund remains in operation to assist persons of British nationality or persons who are married to or divorced from a British citizen. The BCF also helps widows/widowers of British nationals regardless of nationality. Assistance may also be extended to the children of a British national. However, in all cases, the person assisted must be resident in Belgium.



The patron of the BCF is the King of the Belgians and its President is the British Ambassador to Belgium. However, the day-to-day work is run by a small Executive comprising the Chairman, the Treasurer and the Secretary which, together with a Committee of "visitors", meets on a bi-monthly basis to review cases and decide on actions. All are volunteers and running expenses are at the absolute minimum.

The BCF helps persons of all ages, from centenarians to teenagers. Generally, the older

persons are those the BCF assists over a long-term and the younger persons are generally the urgent short-term cases.

The majority of cases are referred to the BCF by the Fund's regional contacts in Antwerp, Charleroi, Ghent and Ypres, by the network of sister organisations in Belgium such as the Community Help Service, the Royal British Legion, RAFA, Holy Trinity Brussels, the Church of Scotland and by the British Embassy.

Joint Social Events: As part of a programme of events to combat social isolation in senior members of the English speaking expat community the Fund has been instrumental in organising a lunch together with the Brussels Branch of the Royal British Legion, The Wednesday Club and the Royal Air Force Association. The Queen's Jubilee was an ideal occasion to bring together senior persons for

a social occasion and was welcomed by the large number of participants who were brought to the venue from a wide area around Brussels by a group of volunteers. Given the positive reception to the joint event a second lunch, called the Harvest Lunch was held in October 2012 and a Spring Lunch is currently being organized for 2013.

Wine Tasting:

A further wine tasting evening was held with the co-operation of Henri de Cressac. The event provided the opportunity to taste a range of excellent French wines at very attractive prices and it promotes the Fund and raises money for it.

Duchess of Richmond's Ball:

The Fund received a substantial donation as a result of the very successful revival of the Duchess of Richmond's Ball which was organised by the BBCA, The British Chamber of Commerce in co-operation with the British Embassy and a number of sponsor companies. The Ball was held at the Chateau St. Anne in June 2012 and a further Ball is planned for 15 June 2013 at the Palais d'Egmont.
